The Town Board of the Town of Chester convened at the Town of Chester Municipal Center, 6307 State Route 9, Chestertown, New York, at 7:00 pm.

**Roll Call:** Supervisor Craig Leggett, Karen DuRose, Mike Packer and Larry Turcotte. Steve Durkish absent.

## **Public Hearing for the Preliminary Budget:**

Supervisor Leggett opened the Public Hearing for the Preliminary Budget at 7:10 pm with the Pledge of Allegiance.

Supervisor Leggett started by explaining the Excel spreadsheets that he provided for the 2018 Budget. Stating that there is currently enough money in each fund to cover the budget as submitted and that would raise taxes by  $3.7\phi$  over last year with an estimated tax rate Town wide of a \$1.547 which is a 2.44% increase.

Mrs. DuRose asked about highway paving. Supervisor Leggett stated that Supervisor Monroe once told him, "you buy a truck one year and you pave the next". The last truck the highway purchased was in 2016 for \$196,000, a loader was purchased in 2017 for \$104,000, a mowing tractor and a pickup were purchased in 2018 and in 2019 the Town will buy a tandem dump truck with plow for \$220,000. Mr. Turcotte wanted to make sure there was an increase for repairs. Supervisor Leggett stated there was a \$20,000 increase.

Supervisor Leggett proposed charging the Town for the water used for snowmaking in the Chestertown Water District and came up with a new schedule for water rates that depends less on real estate taxes to pay for the water system and up the meter rates. Mr. Packer said that something needs to be done with the water by Rite Aid. Supervisor Leggett replied we can apply for grants and also roll over what we didn't use this year so there will be more for water mains in 2019.

Supervisor Leggett stated that John Nick asked for a decrease down to \$77,000 for invasive species after the spreadsheet was done.

Supervisor Leggett would like to adopt the budget this year with only using .1s, .2s, ect. to make it easier during the year.

Izzy Modert from the NWEMS, spoke about going to a fully paid staff which leads to a request for an \$83,000 increase over last year. In prior year the EMS has been using the fund balance to meet their budget. The EMS now has a contract with Schroon Lake for service. Elijah Harrison, NWEMS Board Member, spoke about importance of having a fully staffed paid EMS and the true cost to run an agency. Mrs. DuRose asked if the EMS would be requesting an additional \$83,000 every year. Mr. Harrison replied that the EMS will not be asking for such an increase next year. Mr. Packer asked about payroll. Mr. Modert described in detail the rates and job descriptions for the department.

Supervisor Leggett presented another set of spreadsheets and recommended that the Town go over the tax cap by about the increase of the EMS budget.

A lengthy discussion ensued about employee pay rates and keeping people in our community.

Mr. Packer would like to have another meeting to discuss the budget further.
