Regular Meeting:

Supervisor Leggett opened the Regular Town Board Meeting at 7:00 pm with the Pledge of Allegiance. Supervisor Leggett asked for a moment of silence for Karen DuRose's Mother, Edna Ellsworth Belmore.

RESOLUTION NO. 91 OF 2018: ACCEPT THE MINUTES OF THE REGULAR MEETING APRIL 10, 2018

RESOLVED, to accept the minutes of the Regular Meeting April 10, 2018 as presented. On a motion by Mr. Durkish, seconded by Mr. Turcotte, Resolution No. 91 of 2018 was **ADOPTED**. AYE 4 NO 0

Supervisor Leggett opened Committee Reports at 7:03 pm.

Mr. Durkish stated that the community is happy to see the Town being cleaned up from the storm.

Mr. Turcotte attended the Economic Development Initiative Meeting, which was very productive.

Town Clerk reported the office has received the following communication:

- We have received over 500 data questionnaires back of the 1,100 that were sent out

Supervisor Leggett reported the following:

- Attended the Economic Development Initiative Meeting facilitated by the Chamber of Commerce where they presented their results from the focus groups from the winter
- Spoke to Charter about Phase 3 of Broadband and to SLIC about a fiber optic line
- There has been a 2.9% funding increase in CHIPS
- The Old Chester Garage is in the process of being tested
- \$35,000 is estimated to fix the Health Center

Adam Riley spoke about the Northern Warren Trailblazers request for \$10,000 from Occupancy Tax towards the purchase for a 8 ft x 6 ft drag, Polaris side by side and a trailer. The smaller drag would help connect Schroon Lake to Chester.

RESOLUTION NO. 92 OF 2018: APPROPRIATE \$10,000 FROM OCCUPANCY TAX TO THE NORTHERN WARREN TRAILBLAZERS

WHEREAS, the Northern Warren Trailblazers, Inc maintains snowmobile trails in the Town of Chester that are free to use, and

WHEREAS, snowmobiling is an activity that brings in visitors to the area and supports the tourist business environment, and

WHEREAS, the Northern Warren Trailblazers desires to purchase trail grooming equipment with a useful life 10 years or more that will enhance connections with regional trails and the ability to maintain good trail conditions during periods of little snow, and

WHEREAS, the new grooming equipment can be used at the Dynamite Hill Recreational Area to maintain cross country ski trails,

BE IT RESOLVED, the Town Board awards \$10,000 of Occupancy Tax funds to the North Warren Trailblazers for the purchase of specific trail grooming equipment.

WHEREAS, the Town of Chester has obtained grant funding from NYS for the Pottersville Water District through the NYS Department of State and the Environmental Protection Fund, and **WHEREAS**, requirements of the grant include holding a public meeting for the proposed plans,

BE IT RESOLVED, the Town Board will hold a public meeting at the regular Town Board Meeting on Tuesday, June 12, 2018 to review and hear comment from the public about the proposed Pottersville Water District well and well house renovation project.

WHEREAS, the Pottersville Water District has raised funds for the water supply improvements, **BE IT RESOLVED**, the Supervisor is authorized to request quotes for test boring and supply well drilling for the Pottersville Water District.

WHEREAS, the Town Board established the position of Lake Safety Officer and advertised to fill the position, and

WHEREAS, the Town received one application from a qualified individual, who has been a seasonal employee of the Town,

BE IT RESOLVED, the Town Board authorizes the Supervisor to offer the job of Lake Safety Officer to Richard Konig for a term beginning May 20 and ending October 20, 2018 at a rate of \$16.00 per hour for no more than 300 hours for the season to be paid out of Budget Codes A3120.11 and SP7110.11 with a probationary period of 30 days.

WHEREAS, a qualified applicant was interviewed by the Supervisor and a Town Board member, BE IT RESOLVED, the Town Board authorizes the Supervisor to offer the job of Detail

Gardener/Coordinator to Carol Confer for a term beginning May 14 and ending October 21, 2018 at a rate of \$13.91 per hour for an average of 20 hours per week to be paid out of Budget Codes A7110.1 and A8510.1 with a probationary period of 30 days.

WHEREAS, the Town Board has established the position of Senior Building Maintenance Mechanic, and

WHEREAS, the existing Building Maintenance Mechanic is qualified for the position,

BE IT RESOLVED, the Town Board authorizes the Supervisor to offer the job of Senior Maintenance Mechanic to William Rowell to be paid out of Budget Codes A1620.1 and appropriate Parks & Recreation codes as need be, and

BE IT FURTHER RESOLVED, Senior Building Maintenance Mechanic is a full time CSEA-eligible position at the rate of \$20.98 per hour with a probationary period of 90 days starting May 14, 2018. On a motion by Mr. Turcotte, seconded by Mr. Durkish, Resolution No. 98 of 2018 was ADOPTED.

RESOLUTION NO. 99 OF 2018: TOWN OF CHESTER TO DECLARE INTENT TO BE LEAD

AGENCY FOR SEQRA REVIEW FOR THE PROPOSED ADOPTION OF THE REVISED TOWN OF CHESTER ZONING LAW

WHEREAS, the Town Board recognized the need to update and revise the Town of Chester Zoning Law and Subdivisions Regulations, to better promote the health, safety and general welfare of the residents and property owners of the Town and to protect the property values and aesthetics of the Town; and

WHEREAS, the Town designated a Zoning Ordinance Review Committee in April 2016 to update certain Sections, and has undertaken a multi-year effort to revise and update the zoning law and address the needs of the Town and the community; and

WHEREAS, the proposed action amend Sections of the existing Town of Chester Zoning Law; and **WHEREAS**, the proposed revised Town of Chester Zoning Law improves the structure and integrity of the original law and regulations without significantly altering the intent and provisions of the existing documents;

BE IT RESOLVED, that the Town of Chester Town Board hereby declares its intent to be Lead Agency for SEQRA review of the proposed Zoning Law and directs the Town Clerk to send copies of the proposed local law and regulations, SEQRA Part 1, copy of this Resolution stating the Town Board's intention to be Lead Agency for SEQRA review, to the Adirondack Park Agency, as required by law. WHEREAS, Hudson Headwaters Health Foundation organizes a Care For Kids 5K race for the past 14 years, and

WHEREAS, the Care For Kids race is scheduled for Sunday, July 29, 2018 beginning on Schroon River Road in the Town of Chester and ending at the YMCA Outreach Center in the Town of Horicon,

BE IT RESOLVED, the Town Board authorizes the Supervisor to send a letter of support for the Care For Kids 5K race because it involves use of public roads in the Town of Chester.

WHEREAS, the report determines a certain portions of the building to be unsafe and needs to be removed or repaired,

BE IT RESOLVED, as per Ordinance #2 of 1982 the Town Board shall cause notice to be served on the owner requiring the building to be made safe and secure or removed.

RESOLUTION NO. 103 OF 2018: ACCEPT LIST OF BUILDINGS TO BE INSPECTED BY THE UNSAFE BUILDING INSPECTOR

WHEREAS, the Zoning Administrator has identified 6 properties that may be unsafe,BE IT RESOLVED, the Town Board authorizes the Unsafe Building Inspector to contact the owners ofthe properties and conduct a site inspection and report back to the Town Board with his findings.On a motion by Mr. Durkish, seconded by Mr. Turcotte, Resolution No. 103 of 2018 was ADOPTED.AYE 4NO 0

Supervisor Leggett stated that from the Economic Development Initiative (EDI) Meeting one of the four main categories of the Town is aesthetics wanting to see the community prosper and thrive. The Town is working on beautification on Town property where they can and would like the Town to support the Town Zoning Officer to be more aggressive.

RESOLUTION NO. 104 OF 2018: DIRECT THE ZONING ADMINISTRATOR'S OFFICE TO MORE STRICTLY ENFORCE THE TOWN OF CHESTER ZONING LOCAL LAW

WHEREAS, the Town of Chester has a Comprehensive Master Plan that reflects the vision and the standards of the community, and

WHEREAS, the Town of Chester has adopted and has in effect a Zoning Local Law designed to protect the health, safety, and welfare of the community and to direct development and land use in accordance with the Comprehensive Master Plan, and

WHEREAS, most private property owners, businesses, community organizations, and others abide by the Zoning Local Law and benefit from its application and enforcement, and

WHEREAS, there are and will be instances when the Zoning Local Law is not followed and the community is adversely affected because of it,

BE IT RESOLVED, the Town Board directs the Zoning Office to ensure compliance of the Zoning Local Law so that its intent, as based upon the Comprehensive Master Plan and its updates, is carried out for the benefit of the community in its social, economic, and environmental aspects.

BE IT RESOLVED, the Town Board appoints Barbara Kearney as an Alternate Planning Board Member with a term to begin immediately and end on December 31, 2020.

Supervisor Leggett stated that solar power lights were estimated at about \$22,000 and hard wired lights were estimated at about \$2,500. Mary asked about the Zoning Officer's appointment. Supervisor Leggett stated that the Zoning Officer serves at the pleasure of the Board.

Bill Rowell stated that the recommendation for the boiler was for a water conditioner and the Town has not yet received an estimate. Bill Rowell and Mike Packer recommended using an external flow switch.
