

The Town Board of the Town of Chester convened at the Town of Chester Municipal Center, 6307 State Route 9, Chestertown, New York, at 7:00 pm.

**Roll Call:** Supervisor Craig Leggett, Karen DuRose, Mike Packer, Edna Wells, Steve Durkish and Attorney for the Town, Mark Schachner.

#### **Regular Meeting:**

Supervisor Leggett opened the Regular Town Board Meeting at 7:03 pm with the Pledge of Allegiance.

## RESOLUTION NO. 157 OF 2017: ACCEPT MINUTES OF THE REGULAR MEETING SEPTEMBER 12, 2017, SEPTEMBER 27, 2017 AND OCTOBER 3, 2017

**RESOLVED,** to accept the minutes of the Regular Meeting September 12, 2017, September 27, 2017 and October 3, 2017 as written.

#### **Public Hearings:**

Supervisor Leggett reopened the Public Hearing with the Town Board acting as the Local Board of Health in the matter of **Dale Gleason Septic System Variance**, 649 Atateka Drive at 7:04 pm. Mr. Leggett asked if there were any revisions and stated the Town had not received any new information. Brett Winchip from Winchip Engineering stated there were no revisions. No public comments.

On a motion by Supervisor Leggett, seconded by Mrs. DuRose, the Public Hearing was closed at 7:06 pm.

Supervisor Leggett opened the Public Hearing to establish a **Local Law To Override Tax Levy Limit** Established in General Municipal Law Section 3-C For Fiscal Year 2018 at 7:06 pm. Supervisor Leggett stated the all town in NYS are to abide by a tax levy limit where it cannot go up more than 2% or at the rate of inflation, which this year is 1.84% without passing a local law. Mr. Schachner reminded everyone that adoption of the Local Law does not mean the Town will exceed the tax cap, it only means the Town has the opportunity if it feels the need to.

On a motion by Supervisor Leggett, seconded by Mrs. Wells, the Public Hearing was closed at 7:08 pm.

#### **Committee Reports:**

Supervisor Leggett opened Committee Reports at 7:08 pm.

Mr. Durkish stated that October is Breast Cancer Awareness Month and there are a lot of free programs available.

Mrs. Wells stated that the Youth Commission and the YMCA will be having Family Movie Nights at the Town of Chester Municipal Center the second Friday of every month. The Youth Commission and the Loon Lake Marv Cole Golf Tournament will be sponsoring the Halloween Parade on October 31st, line up at 4:45 pm on Church Street. There will be Trunk or Treat in Pottersville from 5:30 pm - 7:30 pm and at the Horicon Town Hall from 6 pm - 8 pm. The Youth Commission received a donation from the Loon Lake Marv Cole Golf Tournament. Mrs. Wells thanked the Loon Lake Park District Association for they continued support. The Youth Commission will be having a meeting November 7th at 6:30 pm in the Youth Center.

Mrs. DuRose invited everyone to attend the Historical Museum's event on Logging in the Adirondacks by Dick Nason on October 18th at 7 pm.

Supervisor Leggett ask Arnold Jensen to speak on behalf of the Loon Lake Park District Association. Arnold stated that the Loon Lake Marv Cole Tournament raised of \$5,500 this year to give local organizations and scholarships.

Supervisor Leggett stated that the last month has been spent on the Town Budget and the County Budget. There was a movie being filmed on Main Street. Joanne Conley, Warren County Tourism Director toured our town. Senator Betty Little attended the Chamber of Commerce meeting. Greg Beckler, Chamber of Commerce President thanked Senator Little for the signage on the Northway. Senator Little highlighted broadband and bicycling accessibility along roads.

#### **Old Business:**

Supervisor Leggett opened Old Business at 7:18 pm.

Supervisor Leggett introduced Bret Winchip, Winchip Engineering who gave a quick recap on the **Gleason Septic**. Mr. Winchip stated nothing has changed and they were looking to still replace a failed wastewater system. Supervisor Leggett stated the Town has received documentation that the Town Engineer is satisfied with the plans.

#### RESOLUTION NO. 158 OF 2017: APPROVE GLEASON SEPTIC VARIANCE APPLICATION

**WHEREAS**, the Town Board acting as the Local Board of Health has received a completed application and has held a public hearing regarding the Septic Variance Application for property located at 649 Atateka Drive, Chestertown, NY, Tax Map # 120.15-1-16, and

WHEREAS, according to Section 5.060 – Variances of the Town of Chester On-Site Wastewater Treatment Local Law the Local Board of Health may vary or adapt the strict application of any of the requirements of this Ordinance in the case whereby such strict application would result in unnecessary hardship that would deprive the owner of the reasonable use of the land involved, and

**WHEREAS**, no variance in the strict application of any provision of the Ordinance shall be granted by the Local Board of Health unless it shall find all 4 listed criteria applicable, and

**BE IT RESOLVED**, the Town Board acting as the Local Board of Health finds the Gleason septic variance application meets the following criteria:

- a) That there are special circumstances or conditions, fully described in the findings of the Local Board of Health, applying to such land and that such circumstances or conditions are such that strict application of the provisions of this Ordinance would deprive the applicant of the reasonable use of such land.
- b) That the variance would not be materially detrimental to the purposes and objectives of this Ordinance, or to other adjoining properties, or otherwise conflict with the purpose or objectives of any plan or policy of the Town.

c) That, for reasons fully set forth in the findings of the Local Board of Health, the granting of the variance is necessary for the reasonable use of the land and that the variance, as granted by the Local Board of Health, is the minimum variance which would alleviate the specific unnecessary hardship found by the Local Board of Health to affect the applicant.

**BE IT FURTHER RESOLVED**, the Local Board of Health finds the septic system as designed and presented by Winchip Engineering and reviewed by Cedarwood Engineering on behalf of the Town to be the minimum allowable variance to the Town's On-Site Wastewater Treatment Local Law based on site conditions, lot size, and potential impact to adjacent private property and common natural resource (Friends Lake).

**WHEREAS**, a public hearing has been held for Local Law #2 of 2017 that would allow the Town to override the tax levy limit set for the Town by New York State, and

**WHEREAS**, the Town Board has reviewed the Tentative Budget and foresees the potential need to override the tax levy limit set for the Town,

**BE IT RESOLVED**, the Town Board hereby creates Local Law #2 of 2017 A Local Law to Override Tax Levy Limit Established in General Municipal Law ss3-C For Fiscal Year 2018.

WHEREAS, the 3-year contract for black fly control expires December 31, 2017, and

**WHEREAS**, the Town of Chester desires to continue black fly control in certain areas of the Town for the benefit of residents and visitors, and

**WHEREAS**, the Town of Chester has advertised for bids for a renewed 3-year contract for black fly control based on the same specifications as the expiring contract, and

**WHEREAS**, the Town Board has opened and reviewed applicable bids at their October 10<sup>th</sup> regular meeting,

**BE IT RESOLVED**, the Town Board accepts the bid from Bioconservation, Inc. to provide black fly control services from 2018 through 2020 for the amount of \$15,900 per year and hereby authorizes the

Supervisor to sign the contract and directs the Town Clerk to notify the bidder of the award of this contract.

**WHEREAS**, the Adirondack Park Local Government Review Board has been instrumental in helping Adirondack communities by providing strong, unified, effective representation on important Adirondack Park policy issues, and

**WHEREAS**, NYS has cut funding to the Review Board's budget by 53% over the last 6 years and the Review Board has made an appeal to the Town for \$300 in 2017 and 2018 to help fund their activities in representing the interests of local governments in the Adirondacks,

**BE IT RESOLVED**, the Town Board authorizes Supervisor Leggett to sign an agreement with the Adirondack Park Local Government Review Board whereby the Town agrees to pay the Review Board \$300 and the Review Board agrees to provide services beneficial to the Town, and

**BE IT FURTHER RESOLVED**, the Town Board authorizes an appropriation of \$300 to be paid to the Adirondack Park Local Government Review Board in 2017 and 2018.

Debra said there are a lot of entrepreneurs in Town. Debra stated the Chamber was having a Health Insurance Day for their business members. Mr. Packers asked if this was the first phase. Debra said the rest of this year would be the first phase and next year would state phase 2. Supervisor Leggett thanked Debra.

**WHEREAS**, the Town of Chester began an Economic Development Initiative (EDI) in April 2017 with the purpose of providing momentum and direction in the effort to promote the area, retain existing business, recruit new businesses, support local entrepreneurs, and to leverage small successes into larger ones, and

**WHEREAS**, two well-attended public workshop meetings were held and five economic development areas were identified for further attention, and

**WHEREAS**, in order to further guide the EDI process more data and documentation of these economic development areas is needed, and

**WHEREAS**, the North Warren Chamber of Commerce has proposed a research and data analysis project that will strategically guide economic development within the Town, and

**WHEREAS**, Occupancy Tax revenues "shall be allocated for tourism promotion and tourist and convention development by using revenues to enhance the general economy of the County of Warren, and its city, towns and villages, through the promotion of tourist activities, conventions, trade shows, special events and other directly related and supporting activities", and

**WHEREAS**, the economy of Chester and North Warren is heavily tourism-based and the results of such a project will significantly benefit the tourism segment of the economy and guide future use of Occupancy Tax revenues and the Town Board appropriated \$7,000 for Tourism Promotion (A6410.41) in its 2017 budget,

**BE IT RESOLVED**, the Town Board authorizes Supervisor Leggett to sign a Data Research Agreement with the North Warren Chamber of Commerce for a research and data analysis project and appropriates \$7,000 for this purpose from budget code A6410.41.

#### **Pending Items:**

Supervisor Leggett opened pending items at 8:19 pm.

Supervisor Leggett stated the lines on Olmstedville Road are scheduled to be painted next week, weather permitting. Pat Powers asked about the crosswalk. Mr. Leggett stated he is waiting from the engineers on the sidewalk design. Mrs. Wells stated if a crosswalk is installed a light will be needed. Pat Powers asked about lights at the basketball court and the esthetics in Pottersville. Mary Clark asked about the Pottersville Garage.

#### **Privilege of the Floor:**

Supervisor Leggett opened Privilege of the Floor at 8:24 pm.

Melissa Carroll asked for an 8 ft high fence and stated that she is tired of listening to pickle ball. Supervisor Leggett stated the Town had cut the shrubs because they were growing through the fence to the tennis courts without permission. Mr. Leggett asked the Attorney for the Town if there were any issues with the Town building a fence on private property. Mr. Schachner responded that the Town needs written permission to go on the property and a release. Mrs. Carroll stated she does not want Town employees on her property and she will take care of the shrubbery at her own expense. Melissa asked who was going to clean up the debris. Mr. Leggett stated the Town was going to clean it up. Mr. Packer

asked Al Muench if they made quieter pickle balls? Al said he wasn't aware that anyone was playing before 9 am. Mr. Durkish asked if the quotes could include labor so they were responsible.
