Supervisor Leggett opened the Regular Town Board Meeting at 7:03 pm with the Pledge of Allegiance.

#### RESOLUTION NO. 136 OF 2017: ACCEPT MINUTES OF THE REGULAR MEETING AUGUST 8, 2017

**RESOLVED,** to accept the minutes of the Regular Meeting August 8, 2017 as written. On a motion by Mrs. Wells, seconded by Mr. Durkish, Resolution No. 136 of 2017 was **ADOPTED**.

#### **Committee Reports:**

Supervisor Leggett opened Committee Reports at 7:05 pm.

Mrs. Wells asked for a caution light at Valley Farm Road and State Route 9. Mrs. Wells stated she had heard from a few Pottersville residences about a chlorine smell in the water and being unable to drink it. Mr. Monroe, Water Superintendent replied that the well is good and the chlorine has to be there in order for it to be safe and meet NYS standards.

Mrs. DuRose attended the Library and NWEMS meetings. The EMS asked if in kind services could be done as part of the budget. The Attorney for the Town said that plowing could be done as long as the Highway Superintendent agreed. The stop bar is back at Olmstedville Road and State Route 9, put down by Warren County DPW.

Town Clerk reported the following were enclosed in the Board packets:

Supervisor Leggett stated the tax cap for this year is 1.64% which would allow a \$28,000 increase over 2016. The Attorney for the Town reminded everyone that to override the tax cap it must be done by local law subject to public hearing. Richard Woidt from Woidt Engineering reported in a letter the State has accepted his spillway design for Loon Lake Dam, reducing the amount of space needed.

#### **Old Business:**

Supervisor Leggett opened Old Business at 7:17 pm.

Supervisor Leggett introduced Garry Robinson to present on the **Leonard Septic**. Garry states the testing proposed by the engineer for the Town was excessive and expensive. The Leonards are now proposing a 3,000 gallon holding tank with alarm system. Chris Liddle asked if the holding tank had a liner. Garry stated it is a precast holding tank. Mr. Packer asked if Leonards were going to test the stream. Garry stated that there would be no need for Leonards to test since they are now putting in a holding tank. Chris

Liddle asked if the pollution problem was going to be handled in this resolution. Craig stated not in this resolution.

## RESOLUTION NO. 137 OF 2017: APPROVE LEONARD SEPTIC APPLICATION WITH THE CONDITION THAT THE TOWN ENGINEER APPROVES FINAL PLAN

**WHEREAS**, the Town Board acting as the Local Board of Health has received a completed application and has held a public hearing regarding the Septic Variance Application for property located at 24 Atateka Loop, Chestertown, NY, Tax Map # 120.11-1-28, and

**WHEREAS**, according to Section 5.060 – Variances of the Town of Chester On-Site Wastewater Treatment Local Law the Local Board of Health may vary or adapt the strict application of any of the requirements of this Ordinance in the case whereby such strict application would result in unnecessary hardship that would deprive the owner of the reasonable use of the land involved, and

**WHEREAS**, no variance in the strict application of any provision of the Ordinance shall be granted by the Local Board of Health unless it shall find all 4 listed criteria applicable,

**BE IT RESOLVED**, the Town Board acting as the Local Board of Health finds the Leonard septic variance application meets the following criteria:

- a) That there are special circumstances or conditions, fully described in the findings of the Local Board of Health, applying to such land and that such circumstances or conditions are such that strict application of the provisions of this Ordinance would deprive the applicant of the reasonable use of such land.
- b) That the variance would not be materially detrimental to the purposes and objectives of this Ordinance, or to other adjoining properties, or otherwise conflict with the purpose or objectives of any plan or policy of the Town.
- c) That, for reasons fully set forth in the findings of the Local Board of Health, the granting of the variance is necessary for the reasonable use of the land and that the variance, as granted by the Local Board of Health, is the minimum variance which would alleviate the specific unnecessary hardship found by the Local Board of Health to affect the applicant.
- d) In granting any variance, the Local Board of Health shall prescribe and attach any reasonable conditions that it deems to be necessary or desirable.

**BE IT FURTHER RESOLVED**, the Local Board of Health finds a septic holding tank system to be the minimum allowable variance to the Town's On-Site Wastewater Treatment Local Law based on site conditions, lot size, potential impact to adjacent private property and proximity to a common natural resource (Friends Lake), and

**BE IT FURTHER RESOLVED**, the Local Board of Health requires the Engineer for the Town to approve the Leonard septic holding tank system design as a condition for final approval of this variance. On a motion by Mr. Packer, seconded by Mrs. DuRose Resolution No. 137 of 2017 was **ADOPTED**.
