Public Information Meeting:

Supervisor Leggett opened the Public Information Meeting regarding the high levels of lead found in the drinking water in some homes on the Chestertown Water District at 7:09 pm.

Jason Monroe, Water Superintendent for the Town of Chester stated that he has been taking water samples for the Town since August of 2002. This is the first year there has been a spike with two Lead action levels exceedance. Lead is not found in the source of the water, it comes from owners plumbing systems. Mr. Monroe has been testing for 14 years. This year was the first failure. Jason spoke to owner

about any changes made in the past year. They have installed a water softener. Jason has received documentation from the owner to be submit to the Health Department. Jason has taken another round of samples. The results are not ready as of this meeting. For more information please go to www.NewYork.Health.gov.

Mary Clark asked about Pottersville Water District. Jason said the lead action levels are fine.

John Little asked Jason what chemicals are added by the Town. Jason said chlorine and phosphates are added. The phosphates make a slippery film on the inside of the copper pipe. Mr. Little asked what left the brown ring in the toilet. Jason said it was iron and manganese from the water source.

Mrs. DuRose asked about the air in the line in the Pottersville Water District. Jason recommended drilling a new well for the water district.

Supervisor Leggett opened up the privilege of the floor at 7:29 pm.

Al Muench, President of the Library Board of Trustees has accepted the resignation of Nadine Magee from the Library Board. Al would like to thank the Town for allowing pickle ball on the Town courts and John West for taking down the nets.

Pat Powers asked about the street lights in front of the Wells House. Mr. Leggett states the island is owned by the State and the electric was to go to the Wells House but never hooked up. The Highway will hook up the light in the spring when they can cut the road and run a line. Pat asked about Olmstedville Road not being fully paved.

John Nick would like to thank the Highway Department, Parks and Recreation and Mike Packer for the work on Dynamite Hill. Jason has been making snow. There will be a ribbon cutting December 31st at 10 am. The Town Board thanked John Nick for all of his hard work at Dynamite Hill. Arnold Jensen ask when Dynamite was going to open. Jason reported the Hill will be open December 23rd. Tony Taverni commented that Rotary made a large contribution to the renovations at Dynamite.

Pat Powers asked about the Magee property and the change in the zoning laws pertaining to garage sales. Mr. Leggett said it was a work in progress.

Supervisor Leggett closed the Privilege of the Floor at 7:45 pm.

Committee Reports:

Mrs. DuRose reported the Highway hired a new MEO.

Mrs. Wells reported the Adult Walking Program is now taking place at North Warren Central School Mondays and Wednesdays 6 pm - 8 pm and the signups for Gore Mt. Skiing and Snowboarding Program have finished and youth basketball has started.

Mr. Durkish drove through the cemeteries and has a few recommendations for the spring.

Supervisor's Report:

Supervisor Leggett read a letter from Shep and Laura Peck thanking Jason Monroe and the Highway Department for a job well done. Town of Chester has received a \$60,000.00 cash grant with \$60,000.00 match by the Town to upgrade the Pottersville Well House and system. The Town was also approved for a \$6,000.00 grant through the Warren County Soil and Water Conservation District for Friends Lake Watershed Management Plan. The Department of Transportation turned down the request for a speed limit on Palmer Pond Road. Jason has received a lot of complaints about the speed. Supervisor Leggett said the next ZORC (Zoning Ordinance Review Committee) is December 29th at 6 pm. On November 30th the Town of Chester hosted a Planning and Zoning Workshop. Mr. Leggett has received a proposal for a Lake Monitoring System at the dam on Schroon Lake. Landfill monitoring well reports are in form Phoenix Environmental Laboratories, Inc.

Old Business:

Proposed Friends Lake Aquatic Plant Control District:

Tony Taverni asked why an engineer is required and why an easement is required. Attorney for the Town, Mark Schachner, has never said that an engineer is required by the Town, however maps, plans and reports typically are prepared by an engineer. Mr. Leggett said the easement is necessary because there is no public access to Friends Lake and access to carry out the function of the district is needed.

Loon Lake Dam:

Woidt Engineering has proposed a study of a break at the Loon Lake Dam. The proposal amount would not exceed \$10,400.00. The study is needed to reclassify the dam. The last study did not take into consideration the coffer dam.

LOCAL LAW NO. 3 OF 2016

LOCAL LAW AMENDING LOCAL LAW NO. 1 OF 2016 RELATING TO TOWN CONSTABLE AND LOON LAKE CONSTABLE RESIDENCY REQUIREMENT

- **Section 1.** Purpose and Intent It is the purpose and intent of this Local Law to amend Local Law No. 1 of 2016 "A Local Law Amending Local Law No. 1 of 2002 Relating to Loon Lake Constable Residency Requirements", to include all officers in the Town of Chester Constabulary Department.
- **Section 2.** <u>Authority</u> This Local Law is adopted pursuant to Municipal Home Rule Law which grants to every local government the power to adopt and amend local laws not inconsistent with any general law relating to its affairs or government and grants to the local government of a Town the power to adopt and amend Local Laws relating to the qualifications of its officers and employees and to supersede any provision of the Town Law in its application to the Town. This Local Law recognizes that Town Law Section 23 and Public Officers Law Section 3 are special laws in relation to any appointed Town official.
- **Section 3.** <u>Amendment</u> Whereas the Town of Chester Local Law No. 1 of 2002 authorized the creation of a Town Constabulary Department consisting of the existing Town Constable and appointment of a Loon Lake Constable and, whereas the Town of Chester Local Law No. 1 of 2016 amended Local Law No. 1 of 2002 with the addition of a new Section 6 with the intent to exempt the Loon Lake Constable from residency requirements as prescribed by New York Town Law Section 23 and Public Officers Law Section 3 and, whereas the New York State Division of Criminal Justice Services does not specifically recognize the Loon Lake Constable but does recognize the Town Constabulary Department and, whereas to align with the Division of Criminal Justice Services registry, an amendment is hereby made to Local Law No. 1 of 2016 Section 3 by adopting the following revision to the added Section 6:
 - Section 6. Residency; Supersession Persons holding office in the Town of Chester's Town Constabulary Department, including Town Constable and Loon Lake Constable, need not be an elector or resident of the Town of Chester. This provision is intended to supersede the requirements of Town Law Section 23 that a non-elective officer of a town must be an elector of the town at the time of his or her appointment and throughout his or her term and Public Officers Law Section 3 that a person holding a local civil office must be a resident of the political subdivision within which his or her official functions are required to be exercised.
- **Section 4.** <u>Inconsistency, Supersession</u> Any other Local Laws or Ordinances of the Town of Chester that are inconsistent with the provisions of this Local Law are hereby repealed to the extent of such inconsistency. As noted above, Town of Chester Local Law No. 1 of 2016 is specifically amended by this Local Law. This Local Law is specifically intended to supersede the requirements of Town Law Section 23 that a non-elective officer of a town must be an elector of the town at the time of his or her

appointment and throughout his or her term and Public Officers Law Section 3 that a person holding a local civil office must be a resident of the political subdivision within which her or her official functions are required to be exercised.

Section 5. <u>Severability</u> - The invalidity of any clause, sentence, paragraph or provision of this Local Law shall not invalidate any other clause, sentence, paragraph or part hereof.

Section 6. <u>Effective Date</u> - This Local Law shall take effect upon filing by the New York Department of State.

Employee Handbook:

Supervisor Leggett would like to update the employee handbook from 2001 and is asking the board members to look through the employee handbook for changes and recommendations for the January meeting. Mrs. Wells volunteered to meet with Craig to make revisions.

CSEA:

Supervisor Leggett stated there needs to be clarification on retiring while you opt-out from Town provided health insurance plans if you could come back on the Town health insurance. There was discussion whether Vision Gold benefits are paid for by the Town for employees that opt-out of Town health insurance. Lengthy discussion ensued. Mr. Leggett will give an update at the January meeting.

Unsafe Buildings and Procedures:

Town currently has a building in Chestertown that the Zoning Administrator, Mr. Tennyson feels is unsafe. Ordinance #2 of 1982 would need to be followed by the Town Board. Will discuss further at the January meeting.

Boreas Pond:

Supervisor Leggett presented to the Board with a copy of the Access Adirondacks Memorandum of Understanding Among Public and Private Organizations Regarding Recreational Access to Adirondack State Lands. Lengthy discussion ensued.

Supporting Memorandum of Understanding Access Adirondacks

WHEREAS, the Adirondack Park Agency establishes land use classifications for state owned forest preserve lands within the Adirondack Park, and the land use classifications determine the type of activities afforded to the general public within the, boundaries of said property, and

WHEREAS, The Town of Chester advocates that a balanced approach is required in establishing land use classifications in order to adequately protect sensitive natural resources, as well as affording access to a diversity of recreational interests, and

WHEREAS, several Adirondack communities (including Newcomb, North Hudson, Minerva, Indian Lake and Long Lake) drafted and entered into a Memorandum of Understanding titled "Access Adirondacks" that sets forth a position on the classification and management of state owned lands within the Adirondack Park, and

WHEREAS, the "Access Adirondacks" Memorandum of Understanding advocates for a balanced approach to establishing land use classifications for state owned lands within the Park according to their characteristics and capacity to withstand use, that recognizes the historic use of the properties and the economic impact of said classification on the local communities within the Park, **NOW**, **THEREFORE**, **BE IT**

RESOLVED, that the Town of Chester hereby supports a reasonable approach in establishing land use classifications for public lands in the Adirondack Park in order to provide an appropriate levels of public access to these lands, and, be it further

RESOLVED, that the Town of Chester hereby supports and endorses the Memorandum of Understanding titled "Access Adirondacks" by and between the aforementioned Adirondack communities that advocates for a reasonable approach to allowing recreational access for all New Yorkers, regardless of age or physical disability, to state owned lands within the Adirondack Forest Preserve, and, be it further

RESOLVED, that a certified copy of this Resolution be forwarded to Governor Andrew M. Cuomo, Senator Elizabeth O'C Little, Senator-Elect James Tedisco, Assemblyman Dan Stec, Assemblyman Marc Butler and Adirondack Park Agency Chairman Sherman Craig.
