Special meeting of the Town Board of the Town of Chester was held **April 15, 2013** at 6:00 pm in the Town Municipal Center, Chestertown, NY.

Roll Call: Frederick H. Monroe, Karen DuRose, Mike Packer, Edna Wells, and Steve Durkish.

The purpose of the Special meeting was to reconsider the Notice to Bidders and the way we bid for our sand.

The meeting was called to order, and Supervisor Monroe stated that he had talked with Highway Superintendent, Jason Monroe, and they had agreed that we should change our Notice to Bidders for bank run sand from a requirement of being located within a 10 mile radius to a 15 mile radius from the Highway garage. Jason stated that with six (6) trucks, they can haul approximately 1370 yards per day, which would take about 9 days to lay up the sand. The trucks get about 8 miles per gallon of fuel, so our price for hauling would depend on distance traveled.

RESOLUTION #61: RESCIND RESOLUTION #49.

Introduced by Mr. Monroe, seconded by Mrs. Wells, rescind Resolution #49 which called for bid openings for bank run sand to be opened on April 22, 2013, and for bidders to be located within 10 miles of the Highway garage. (All bids were rejected at the April $9^{\rm th}$ meeting).
