Supervisor Leggett **opened** the Regular Town Board Meeting at 7:00 pm with the Pledge of Allegiance led by Councilman Packer.

On behalf of the Town Board, we wish you the best in your future endeavors. You served the Town long and well.

#### **Town Board Reports:**

Councilperson Aiken reported that he attended CSEA meetings, the Rotary Memory Tree lighting, the Rotary Christmas with Santa that was held last Saturday and as part of his report he would like to thank Councilman for everything he has done for Town, thanks Mike for your many years of service and dedication. He would also like to thank Supervisor Leggett for his

vision, dedication, hard work, and results that he has delivered through his tenure as Town Supervisor. His record speaks for itself, but for those who are unfamiliar with that record he would like to note of Supervisor Leggett's work over the past eight (8) years, which include: bringing the Loon Lake Dam project, new highway garage, Chester water upgrade to a point being funded, a three (3) million-dollar fund balance, a revitalized downtown, the retention of the North Warren EMS, Farmers Market, Christmas light on the front lawn, Pottersville Christmas lighting, major upgrades to the Town's gymnasium including flooring lights and new bleachers, a dog park, a Senior Center, a Daycare Center, continued Loon Lake milfoil control funding, town access to Friends Lake, combined Chester/Johnsburg Fire District, paving 160 miles of town roads, expansion of broadband, internet, and cell service, townwide cleanup including the demolition of the old Chester Garage, adding two (2) hike to the Chester Challenge, adding the Cunningham Loop Recreational Trails, a snow gun and multiple other enhancements at Dynamite Hill, made Pottersville Playground and other enhancements, helped with rehab of the Darrowsville and Pottersville Cemeteries, worked on getting additional pickleball courts and a Chestertown Playground, big support for the Historical Society, library and food pantry, new town trucks, purchase of the Priory property which has incredible potential for our town, navigating the STR (Short-Term Rental) regulations to help keep NYS out of our local business, all of the accomplishment that will help maintain this town keep its competitive advantage for year to come. Notably as well is Craig's hard work on the County Board of Supervisors, which has not only helped make Warren County a better place to live but our town as well.

Supervisor Leggett thanked Chris Aiken.

Councilman Packer said he had nothing important. He did the audit with Karen DuRose.

Councilwoman DuRose thanked Mike for everything he has done and Craig, Chris hit the nail on the head saying what you did. Craig did a great job leading us forward the last eight years. Karen said she attended the Zoning Board Meeting by Zoom, had many phone calls concerning the holiday lights which came together and all the remarks on Facebook were wonderful, and a majority of her time was spent with Michael Packer doing audits.

Councilman Turcotte said that this month he spent a lot of time on the highway garage, attended a meeting with the design engineer doing the plans and he is basically ready to move on to the next phase pending our approval, we got some preliminary cost estimates, and he is currently working with him to go over some materials to reduce some costs. He spoke with the Highway Superintendent about construction types and materials. Had a lot of phone calls to make sure everyone was on board, and he was not just going down some dead-end road.

(Town Clerk noted there were technical difficulties and had to restart Zoom)

Councilman Turcotte continued said there were a lot of correspondence on the highway garage. He thanked Craig for his term in office he thinks Chris hit the nail on the head and he can't really follow up any better than that and he knows the Town is in a better position now than when we started, and he looks forward to the fruits of his efforts for years to come. The real impact of an administration isn't known for decades later sometimes. Thank you.

Supervisor Leggett thanked everyone and said that it is a Board effort. One thing Fred Monroe said was that he can't do anything by himself, it is the Town Board that makes the vote on things.

#### **Supervisor's Report:**



When he ran eight (8) years ago it was on the platform of fiscal conservatism and forward thinking.

We have a beautiful place to start here with our town hall that houses quite a lot.



This gives you an idea of fiscally conservative, that

over the last eight (8) years if you have a \$200,00 home you are paying \$12.40 more than you were eight years ago. Our taxable assessment went up 52 million dollars and our asset on just property and building have gone up 1.8 million dollars and that does not include all of our vehicles.

Soil and Water Conservation to be able to keep sediments out of Loon Lake.






Here is John West who retired, we had a lot of retirements over

Also, one of the first things during that first year was making space and a place for the pellet fired steam boiler.




We supported the Historical Society for the dedication of Darrowsville Church.






Pottersville.

Memorial Day Parades are always a good turnout.










Another thing we did was to paint the old water tank up on Spring Street, the Chestertown water tank.

#### **Privilege of the Floor:**

Supervisor Leggett **opened** Privilege of the Floor at 7:36 pm.

Supervisor Leggett asked if anyone from the public wished to speak.

Marion Eagan thanked Mike Packer for his dedication. Mike was here when this building was started and was very instrumental in getting it up and getting it to where it is today. She also congratulated John Maday, Jenna Cooper and Chris Aiken and she would especially like to thank Craig Leggett for an outstanding job as Supervisor for the Town of Chester. She knows that she does not speak for herself when saying that it has been an honor and great pleasure working for him. He has created a work environment that brought out the best in his employees. He listened and supported us every step of the way from the Highway Department, Parks and Rec., and all of here in the Municipal Center. The last eight years have brought some challenges. We had the Halloween storm which left this town with a quarter of a million dollars' worth of damage. He moved swiftly and safely to protect the community from a true disaster. When that was complete, he made sure we diligently worked on getting our money back. We worked through the covid pandemic, sending our Highway Department home to make sure their health and safety were top priority. When the Municipal Center had to shut down, you made sure that all the employees that were sent home had the proper equipment to keep them working and for those of us who came in progress continued. If she was to list all of his accomplishments, we would be here until the next board meeting. So, she is not going to talk about the roads, the culverts, the bridges, the compactors, the transfer station updates, and 125 new LED lights. Proudly she can say without him this Town would not have a YMCA, a Senior Center, a Daycare Center, Turning Leaf Counseling, an in -house caseworker, indoor gymnasium, updated technology, and website, and when you drive out of here tonight look at those beautiful lights. None of this was here eight (8) years ago. As a community leader he made it a point to attend high school graduations, preschool graduations, baccalaureates, National Honor Society Awards, basketball games, Main Street events, Down Hill Derbies, Rotary, Tri-Lakes Business Alliance, Chamber of Commerce Meetings, and let's not forget his weekly visit to the Farmers Market. He was active and present in every group, alliance and foundation that had anything to do with the Adirondack Park continuing our Town presence which proved to be enormously valuable. At the County he sat on countless committees, too many to name. Supervisor was not a job for him, it was a way of life. Twenty-four (24) hours a day, seven (7) days a week he was always available. So, thank you for your dedication, kind manner, and your leadership. You will be missed by all.

Supervisor Leggett said thank you.

John Nick said that his wife, Jo Anne and he have been here almost twenty (20) years, and it has been enjoyable for us. John Nick thanked Craig Leggett for the last eight (8) years. His support with Rotary, Loon Lake, and Loon Lake Park District Association has been inspirational. There have been a lot of projects completed and Chris Aiken mentioned them. The one closest to his heart is Dynamite Hill. His dad started him skiing when he was seven (7), he skied this morning, so he has been skiing awhile. He drives by Dynamite Hill at night and sees kids out there that were his age when he started skiing, it's good to see. That project we brought in new power system with National Grid, Mike Packer installed lights, LED lights in place of the old ones and new one on the side. A new lift, Chis Aiken built the base. It is just a great project for the Town. The Loon Lake Dam is on its way, which is sorely needed. The invasive species has been

reduced over the past eight (8) years in Loon Lake, but we still have work to do. The Loon Lake Park District Association will be there to support the Town like they have in the past. He can't tell you how great the lights look. John Nick thanked Craig Leggett very much and said he was always available no matter when he called.

The Town Clerk said that Doris O. commented on Zoom, thank you for your service.

Supervisor Leggett said thank you and thanked you to Mike Packer for Dynamite Hill. It really took a team effort and Mike led the way to getting all the electrical figured out.

Bernie McCann said that he remembered Craig about two (2) months before his first election standing on Riverside Drive on the corner and the two (2) of them and Craig started talking about what the Town could look like. Bernie said he got so excited because Craig brought energy, brought foresight, Craig brought this Town along. Sometimes it was kicking and screaming but Craig brought it along and this Saturdays event that brought all the merchants were taking part in and all the people were walking up and down the streets was proof that what Craig did and has a satisfactory ending. Bernie also thanked Craig for the Historical Society for what he did for the Sumy Exhibit, you stepped right up and said you would mc it. Everything he asked for Craig gave them and he can't thank Craig enough and thanked Craig for his time and service.

Kayla Carlozi, former employee for the YMCA, a Board Member of Small Tales, and the Executive Director of North Country Ministry, she could not be more proud to work with Craig to be the gym here, the daycare here, and now our caseworker who is here to serve the Town of Chester so that our clients can come here to us. She cannot thank Craig enough. Working with Craig has been amazing. Congratulations and thank you for all you have done.

Supervisor Leggett said thank you.

Michael Dittmer commented that he has only been working with the town for about a year now and it has been a long year. We have gotten a lot done changing two (2) rooms. It all came to fruition in August with all the hard work of Marion Eagan and the Town Boards approval. Michael gave Craig a photo for the ribbon cutting for the daycare for everything he helped them achieve and said that it looks like the daycare will open in January.

Supervisor Leggett said thank you for taking a chance with us.

#### **Old Business:**

Supervisor Leggett **opened** Old Business at 7:36 pm by saying that he was taught to leave a place better than you have found it.

Judith Harris said that she has never been to a board meeting before. Her husband, years ago, served on the Zoning Board and she loves this Town. She feels so connected, and so safe, and when we went through covid this was a great place. Mindy Conway was a rockstar. The care Craig showed our community, she felt proud to be a member of this community and especially over the last four (4) years when there's been a lot of turmoil in our country and the world, she feels like this is a great safe place. She is incredibly grateful for the care Craig has taken towards

our community, the Board as well. It's a great place to live and it is even a better place than it was twelve (12) years ago and she is proud to be here, a taxpayer in this town. Thank you.

#### **Highway Garage:**

Supervisor Leggett said that he interviewed one individual that applied for clerk of the works, and we are not going to take any action tonight.

Supervisor Leggett said that as Councilman Turcotte said we had met with the engineer and the layout is good, but we do have questions about the overall design and material to use.

#### **Grant Updates:**

Supervisor Leggett said we have not heard back about the Loon Lake Dam Grant and Rehabilitation Project, we did not get the Chestertown Water District Grant Application, and then the Environmental Protection Fund Grant Program for Parks, Recreation and Historic Preservation CFA (Consolidated Funding Application) Application #129230 for pickleball and playground we did not get either.

Councilman Turcotte asked if they gave us reasons. Deputy Supervisor Eagan said that they gave us all the reasons. We scored super high; she said our zip code didn't match where they were they giving out this year and the only thing that we were missing and she really wants us to apply and will walk us through it, is the actual architectural drawing. The highest score that was received was 56 and we had 48. So, we did really good, and she knew that the architectural renderings were going to be a stickler, but it was to save money.

#### **Municipal Center:**

Supervisor Leggett said we just heard from Michael Dittmer about Small Tales that will be coming up soon.

Supervisor Leggett said that we have a few applications for an evening cleaner, and we will put that off for another month.

#### 225<sup>th</sup> Anniversary of the Town:

Supervisor Leggett asked Bernie McCann if there were any updates.

Bernie McCann said they have a prototype of the actual plaques that they are going to put on the 51 houses that were built before 1800. He will leave it in the Town Clerk's Office for people to look at. They are moving ahead with the selection of photographs of the Town through the

different time periods. Some of the early photographs are just amazing. Bernie thinks this will be as good if not better than the Sumy Exhibit. They are looking to have at least 300 photographs, they have started scanning them already, so they should be all set by July 13<sup>th</sup>.

Supervisor Leggett commented that when a town has historical designations on a house or a district it all helps with grant scoring. Thank you, Historical Society, for helping to line us up for funding.

#### **Alternate energy supply:**

Supervisor Leggett spoke with Brian Buzby from Ampion and he mentioned last month that Mega takes care of the supply, but on the distribution costs we still pay the same rate. If you get onto community solar and buildings that do not already have solar get 10% off their rates. Supervisor Leggett would like the Board to continue to look and get a contract signed to keep these prices down.

#### **Property Maintenance Local Law:**

Supervisor Leggett said that they introduced this last meeting, had a public hearing this meeting and now they are ready to take action.

## RESOLUTION NO. 173 OF 2023: RESOLUTION ADOPTING LOCAL LAW NO. 7 OF 2023 AMENDING LOCAL LAW 1 OF 2019 ENTITLED "A LOCAL LAW TO ESTABLISH PROPERTY MAINTENANCE LOCAL LAW"

**WHEREAS**, the Chester Town Board wishes to consider adoption of Local Law No.: 7 of 2023 to amend Local Law 1 of 2019 entitled "A Local Law to Establish Property Maintenance Local Law"; and

**WHEREAS**, this legislation is authorized in accordance with New York Municipal Home Rule Law §10; and

WHEREAS, cellular service is vital to public safety and the economic wellbeing of communities throughout the Adirondack Park; and

**WHEREAS**, county officials report that approximately 70 percent of 9-1-1 calls originate from cellular phones; and

WHEREAS, in a recent survey hosted on a State Senate website of almost 2,000 Adirondack Park residents, 99 percent of respondents reported owning a cellular phone and 67 percent reported that they rely exclusively on a cellular phone; and

WHEREAS, dependency on cellular service is significant and growing, which speaks to the absolute necessity of improved coverage and service; and

WHEREAS, the State of New York helped respond to this reality in the North Country by working aggressively to deploy COWS (Cells On Wheels) to provide adequate emergency response capacity to serve visitors to the World University Games; and

**WHEREAS**, state officials are proposing that Empire State Development (ESD) designate a point person to coordinate the state's efforts to enhance cellular coverage, similar to the manner in which ESD designated a point person to coordinate the state's efforts to expand broadband coverage; and

**WHEREAS**, the Office of Renewable Energy Siting (ORES), which works to align all state agencies and state policy regarding renewable energy siting and implementation, serves as another successful example of the state coordinating its strategy on important infrastructure matters; and

WHEREAS, barriers to achieving the state's goals with respect to both broadband and cellular coverage enhancement continue to exist within some state agencies, including but not limited to NYSDOT right-of-way requirements, tax policy, and APA restrictions, and an approach similar to ORES would be beneficial in overcoming these barriers; and

**WHEREAS**, improving broadband and cellular coverage is a safety issue, a public imperative widely demanded by our constituents, and has become increasingly regarded as a basic necessity; and

**WHEREAS**, some state policies, especially the APA's "substantial invisibility" standard, are not keeping pace with these trends and instead becoming antiquated and counterproductive from the perspective of emergency services best-practices in place elsewhere in New York State, including co-location of multiple telecommunication systems on cell towers; and

WHEREAS, APA's longstanding claim that the telecommunications industry does not oppose the "substantial invisibility" standard is inaccurate, demonstrated most recently in comments entered by Nixon Peabody into review of the 2002 APA Tower Policy, which recommend "that the Agency modify its 2002 policy that requires telecommunications facilities over 40' tall be 'substantially invisible,'" and which characterize that requirement as an "arbitrary standard [that] is the main impediment to delivering much needed reliable wireless telecommunications service to a greater portion of the Park;" and

WHEREAS, the general public is increasingly supportive of common sense policy changes that promote a more appropriate balance between public safety and aesthetics while maintaining sensitivity to the environment, as reflected in the aforementioned public opinion survey, in which 90 percent of respondents supported changes to the APA's "substantial invisibility" standard; and

WHEREAS, the state has begun taking steps indicating that policymakers recognize these challenges, including the issuance of Empire State Development's Upstate Cellular Coverage Task Force Final Report and APA's advancement of a General Permit to assist with cellular coverage expansion; now, therefore, be it

**RESOLVED,** that the Town of Chester hereby supports the proposed designation by ESD of a point person to coordinate the state's efforts to enhance cellular coverage, and formally asks Governor Kathy Hochul to further enhance the state's efforts on broadband and cellular coverage expansion by employing a model similar to ORES that is respectful of the home rule process and designed to streamline policymaking across state agencies in pursuit of moving the state more expeditiously toward its goals; and be it further

**RESOLVED**, that the Town of Chester hereby joins emergency service and telecommunication professionals, and other towns and villages across the Adirondacks, in urging the APA and the Governor to review the 2002 APA Tower Policy's antiquated "substantial invisibility" standard, which stands as the main impediment to delivering reliable telecommunication services necessary for public safety in large portions of the Adirondack Park; and be it further
